  - **a.** The Fiscal 2024-2025 financial statements were printed in the bulletin.
  - **b.** Our objective to break even financially was met.
  - **c.** There was only a small subsidy from the church to the school in this fiscal year.
  - **d.** We do have a "rainy day fund" in savings just in case of an emergency.
