III. CHAIRMAN'S COMMENTS

- a. Reminder that on October 19th and 20th, Parish Council will introduce themselves during mass.
- b. Reminder for the commission representatives to complete goal #2, objective #1 and turn in by November 30th.

IV. FR. JIM'S COMMENTS

- a. Discussed volunteer of the month and stated that commissions can be creative with their form of announcements.
- b. Announced the start of a women's prayer group and stated that the specific structure of the prayer group is flexible and currently being developed.

V. COMMITTEE REPORTS

- a. CHRISTIAN SERVICE
 - Reminder that if a group is using the AV room to please return things to where you found them and not to stack chairs, as some people have difficulty unstacking them.
- b. EDUCATION Commented that some parishioners have stated the pews appear dirty. Fr. Jim assured Council that pews are cleaned and maintained regularly, and pews upholstery does not change appearance with cleaning due to age.
- c. FINANCE
 - i. Thanked Bob Calleja from St. Edith maintenance for his recent efforts with power washing and cleaning the front of the church.
 - ii. Addressed the prior year's expenditures and gave reminder that St. Edith has a rainy day fund to accommodate years with necessary extra expenditures.
 - iii. Discussed accessible push-button for men and women's bathroom in church hallway. Knights of Columbus Representative advised that they

- will be unable to assist with funding for this, so finance committee will approximate cost for purchase and installation of devices and discuss results at future meeting.
- iv. Advised that they are assessing the installation of LED lighting in front parking lot. They will see if it is possible to install LED lighting on the back lot, but Villa Marie owns and controls the light poles behind the church. Stated that there is no current rebate program through DTE for LED lights, but it was suggested this may change at start of next year.

d. SENIORS

i. Contributed to discussion regarding request for accessible push button for men and women's bathrooms.
